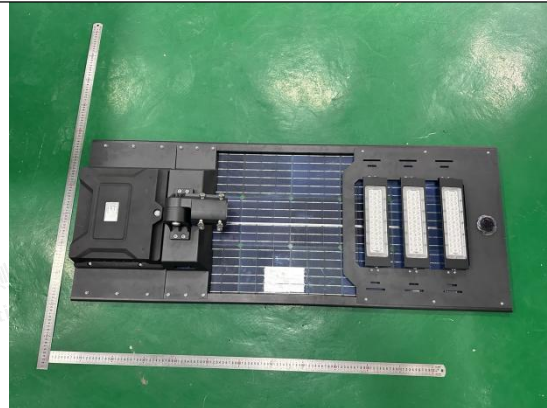

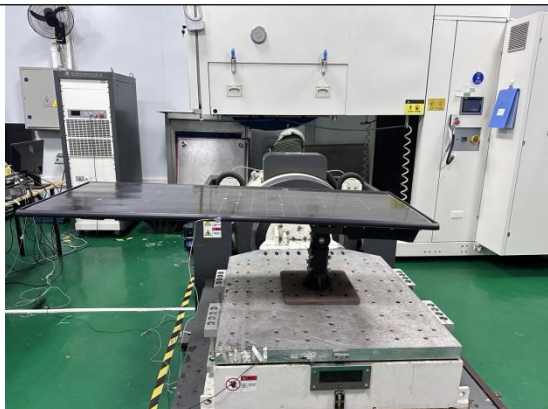


Appearance Inspection-Back

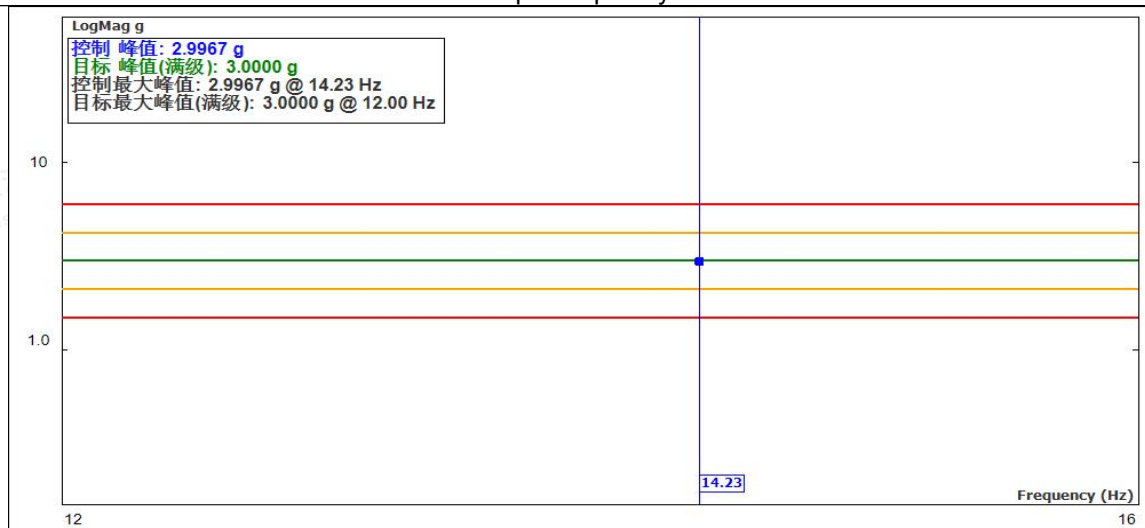

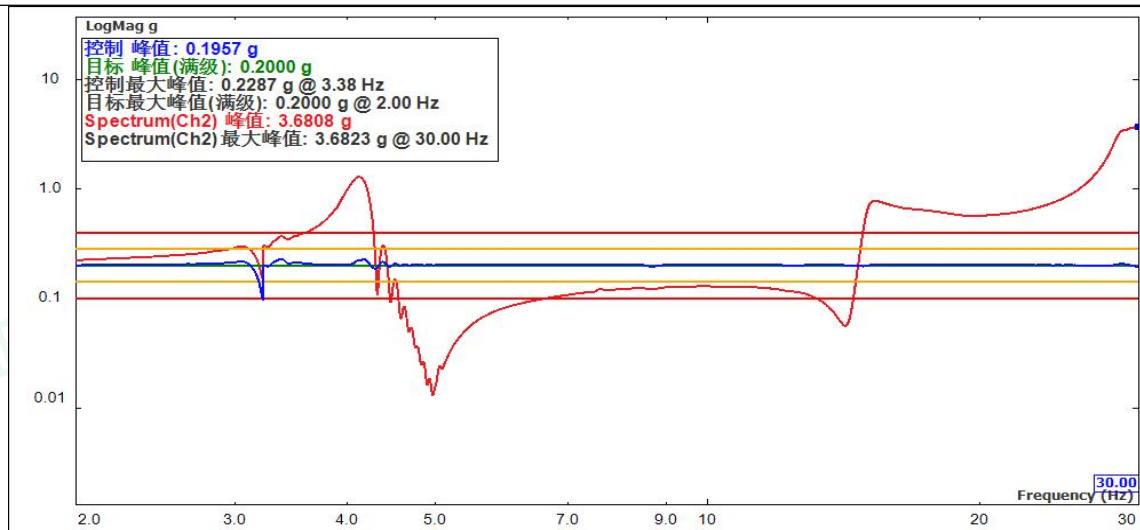

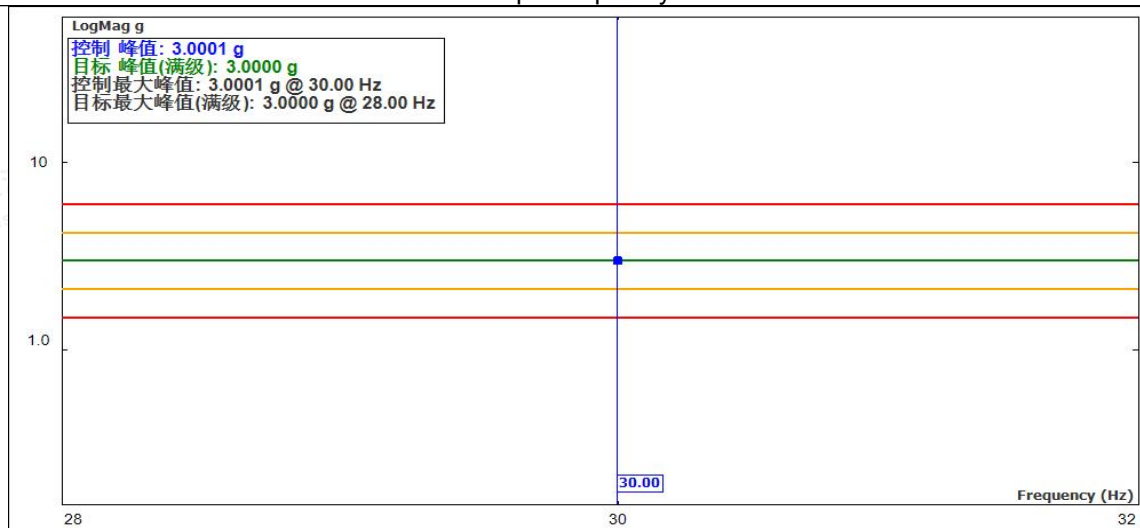
